- A motion was made to approve the payment of bills from the Fire Department. All in favor and all approved.
- A motion was made to award the contract to Verardi Landscapes LLC for the GTRP grant contract. All in favor and all approved.
- A motion was made to pay \$458.00 to paint no parking lines in front of Fire Department. All in favor and all approved.

lost all their fire equipment in a flood.

## **MAYOR'S REPORT**

#### MAINTENANCE REPORT

 Working to get some of the alleys repaired, but this is a two-man job. We are still looking for a part-time helper for maintenance.

#### **ENGINEER REPORT**

- Dominic Grieves of EADS, explained that the opening of bids for the GTRP grant took place at the Borough building on June 16. He revealed that Verardi Landscapes LLC was the lowest bidder and explained the cost breakdown of the bids. This grant will be used at the park for additional work such as: adding the concrete under the pavilion, walkways and ADA compliant parking.
- Discussed the possibility of doing a weight restriction study. If we want the roads to be weight restricted, we would have to pay the engineers to do a traffic study in order for that to be recognized and enforceable in the state of Pennsylvania. Chief Warren asked that he serve as Motor Carrier Enforcement details to follow.

#### **GENERAL DISCUSSION**

- Some complaints were received about the IMBS club. Chief Warren has been in touch with the new Manager and he really wants to make changes and improve on the complaints in the past. The Chief will talk to him again.
- Discussed solicitation in town by vendors, which has become a problem. There were <u>no</u> permits given to any solicitors. It was decided our solicitation ordinance #220 needs to be revised.
- It was decided to let Richardson Inspection proceed with next steps for the property on 6<sup>th</sup> Avenue.
