Requirements

- Must be licensed by January 1
- Required for all dogs 3 months of age and older

Annual dog licenses are valid for the calendar year, January 1st through December 31st of each year.

Lifetime dog licenses are also available for purchase and DO NOT NEED TO BE RENEWED. Microchips are mandatory for the purchase of Lifetime Licenses

Yearly Fees - Use the Dog License Application

\$8.50 for male or female and non-senior citizen

\$6.50 for a neutered male or spayed female and non senior citizen

• Duplicate licenses are available at the Beaver County Treasurer's Office for \$1.50.

Disabled Person's - Use the Dog License Application

You should provide a copy of your Social Security Disability or SSI award letter. – Please redact any personal information from the forms before giving to the Treasurer's office.

Person with a disability is as follows:

"a person who receives disability insurance or supplemental security income for the aged, blind or disabled under the Social Security Act (49 Stat. 620, 42 U.S.C. Section 301 et seq.), or who receives a rent or property tax rebate under the act of March 11, 1971 (P.L. 104, No. 3), known as the Senior Citizens Rebate and Assistance Act, on account of disability, or who has a handicapped plate under 75 PA.C.S. Section 1338 (relating to handicapped plate and placard)."

Disabled Person's Dog License Fees

\$6.50 for a male or female

\$4.50 for a neutered male or spayed female

Lifetime License – Use the Lifetime Dog License and the Permanent Identification Verification Form

\$51.50 for male or female

\$31.50 for neutered male or spayed female

\$31.50 for male or female for disabled person

\$21.50 for a neutered male or spayed female for a disabled person

- If your pet is microchipped, it is eligible for a Lifetime dog license.
- For Lifetime Dog License you must have **both** application and permanent identification form completed. The ID verification is to be signed by the Veterinarian:
 - Lifetime Dog License Application
 - Permanent Identification Verification Form
 - Dog License for yearly license & seniors & person with a disability

Remember

The application must be signed by the dog owner.

Dog owners moving into Beaver County will need to purchase a Beaver County Dog License from the Treasurer's Office. A dog license from another county does not transfer and is not valid within Beaver County, PA. ADLEB 14-18 rev. 9/2014
