

## RESOLUTION 1-2022

### BOROUGH OF KOPPEL, BEAVER COUNTY, PENNSYLVANIA, FIXING THE TAX RATE OF REAL ESTATE FOR THE FISCAL YEAR 2022.

Section 1302 of the Pennsylvania Borough Code generally empowers borough councils to levy taxes “by resolution for taxes levied at the same rate as or a rate lower than the previous fiscal year,” 8 Pa.C.S.A. § 1302(a);

Section 1310.1 of the Borough Code, in particular, provides that “[a]fter council has adopted the budget, it is the duty of the council to adopt a resolution levying the taxes referred to in this part for the fiscal year for taxes levied at the same rate as or a rate lower than the previous fiscal year... subject to approval of the mayor or enactment over the mayor's veto under the procedure established in section 3301.3(c) (relating to enactment, approval and veto),” 8 Pa.C.S.A. § 1310.1;

Thereby, the following:

A RESOLUTION ESTABLISHING A TAX RATE FOR THE FISCAL YEAR OF 2022 OF **18 MILLS** ON THE DOLLAR ON THE VALUATION ASSESSED FOR COUNTY PURPOSES ON ALL PROPERTY WITHIN THE BOROUGH OF KOPPEL WHICH HAS BEEN MADE TAXABLE BY THE LAWS OF THE COMMONWEALTH OF PENNSYLVANIA FOR COUNTY RATES AND LEVIES;

BE IT ENACTED AND RESOLVED BY THE TOWN Council of the Borough of Koppel, and hereby desires to establish the real estate tax rate of 18 mills for the fiscal year 2022 as the same rate as the previous year.

SECTION 1. For the purpose of providing sufficient revenue for the payment of ordinary current operating expenses of the Borough of Koppel, and for the payment of other liabilities, due or those to become due during the said year the following taxes shall be and are hereby levied and assessed against taxable real estate property within said Borough.

SECTION 2. This tax shall be collected at discount until August 31, 2022 it shall be collected at face until October 30, 2022 and it shall be collected at penalty from November 2022 through December 2022.


SECTION 3. It is dictated to be the intention of the town council for the borough of Koppel and it is hereby ordained by authority of the same that all revenue producing resolutions hereto FORENACTED and not repealed, be and are hereby extended and continued during the calendar year 2022.

SECTION 4. SEVEREABILITY: If any sentence or clause or section or part of this resolution is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining clauses, provisions, sentences or parts of this ordinance. It is hereby declared by the intent of Council that this Resolution would have been adopted as such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

SECTION 5. EFFECTIVE DATE. This Resolution shall become effective immediately after its adoption, as provided by law, unless stated otherwise herein.
